Space Debris ist eine deutsche Band aus dem Odenwald, die Musik in der Tradition des Kraut-, Psychedelic- und Hard Rocks der frühen 1970er Jahre produziert.

Stil

Die Band verbindet Stilmittel des Krautrock (Can, Birth Control, Amon Düül, etc.) und des frühen, britischen Psychedelic-Rock (Pink Floyd, Deep Purple, Brian Auger etc.) zu einer eigenen homogenen Musik. Von der Musik-Presse (Moonhead-Magazin März/2005) wurde Space Debris deshalb als *bisher fehlendes Bindeglied* zwischen diesen beiden musikhistorischen Polen bezeichnet. Dabei bedient sich die Band des von der Krautband *Can* maßgeblich vorangetragenen Konzepts der *Spontankompositionen*, indem aus freiem Spiel ohne Absprachen ein kompositorisches Gerüst entsteht, das melodiös und rhythmisch Bestand hat.

Geschichte

Konzeptionell und namentlich aus der Taufe gehoben wurde die Band 2001 von Christian Jäger, der neben dem Schlagzeugspiel für die Aufnahme der Musik, den Schnitt und das Mastering sowie für Artwork und Produktion und sogar Vertrieb der Tonträger zuständig ist. Gründungsmitglieder sind Tommy Gorny (Gitarre/selten auch Bassgitarre) und Tom Kunkel (Orgel), der mit seinem ausdrucksstarken Spiel den Stil der Band maßgeblich prägte. Bisher wurden neun Platten in Eigenregie produziert, die jeweils als CD und zum Großteil auch auf Schallplatte vorliegen. Dabei wurde die Band im eigenen Studio immer wieder durch verschiedene Gastmusiker verstärkt. Die ersten zwei Doppel-LPs sind seit 2009 ausverkauft. Zudem gibt es eine DVD, die auch als CD-Version über das Label *in-akustik* und den Herzberg-Verlag erschienen ist.

Sowohl mit ihrer dritten LP *Three*, als auch mit der vierten *Elephant Moon*, schaffte es die Band jeweils in die Rangliste der besten Jahresveröffentlichungen der Leser des *Eclipsed-Rockmagazins*. Sie hatte Auftritte beim Burg-Herzberg-Festival 2006 (gefilmt unter anderem für den WDR-Rockpalast) und auf der Zappanale 2007 sowie auch 2008 in Belgien und 2009 mehrmals in der Schweiz. Nach der 2008 veröffentlichten und aufwändig gestalteten Triple LP *Elephant Moon* gab es einen maßgeblichen Besetzungswechsel. Das Trio wuchs durch den neuen Bassisten Peter Brettel zum Quartett und Winnie Rimbach-Sator stieg nach zwei erfolgreichen Gastauftritten fest als neuer Keyboarder in die Band ein. Die Band spielte in dieser Besetzung die im Mai 2009 veröffentlichte CD *Live Ghosts* ein, die im Frühjahr 2010 durch die Mithilfe des Labels *Green Brain* auch als DLP inklusive dreier Bonusongs veröffentlicht werden konnte. Seit 2011 hat die Band drei weitere CDs im Programm: *Archive Vol. 1–3*. Bemerkenswert ist ein 30 Min.- Stück mit dem Titel: *Journey To The Starglow Restaurant*. Die Archive-CDs enthalten Aufnahmen aus allen Bandbesetzungen seit Gründung der Band. Mit diesen Veröffentlichungen feiert die Band ihr zehnjähriges Bestehen.

0. PREAMBLE

If you have Invariant Sections without Cover Texts, or some other combination of the three, merge those two alternatives to suit the situation.

If your document contains nontrivial examples of program code, we recommend releasing these examples in parallel under your choice of free software license, such as the GNU General Public License, to permit their use in free software.
